The conference therefore seeks stimulating papers that provoke thoughts and share and extend knowledge, practice, and techniques. Analytical and empirical papers are both welcome. With these topics, we would like to cover all economic, social, political, and technical factors that influence decisionmaking aimed at value creation in the social and economic field.

Thus, any paper corresponding to this broadly conceived theme of the conference would be welcome.

The conference will be held in English.

Paper Submission and Review Process

Participants wishing to present a paper should submit an **extended/detailed abstract (length is min. 400 words and max. 1000 words)** in English by **February 28, 2012** to the Organizing Committee.

Abstracts **should state clearly the purpose, methodology, results and conclusions** of the work to be presented in the final paper. 3–8 key words are recommended. Please include author's full name, affiliations, mailing address, telephone, fax numbers and e-mail address. All abstracts will be peer-reviewed and authors will receive feedback from the Organizing Committee as soon as possible but not later than by **February 28, 2013**. It is also possible to submit the abstract in electronic form at <u>http://www.icabr.com</u>.

Full paper must be submitted by March 28, 2013.

Papers will be presented and after the peer-reviewed process, published only with fully confirmed **registration and payment.** The registration form can be found at <u>http://www.icabr.com</u>.

Format for Paper Submission

- Length limit: approximately 5000 words for text, excluding abstract, diagrams tables and references
 - The first page should contain in the following order:
 - o Title
 - o Name(s)
 - Institutional affiliation(s)
 - o Abstract
 - \circ Keywords
- The beginning of the paper with the instruction
- The final section will be the references in APA style

Conference Proceedings

The full papers will be published on a CD-ROM ISBN 978-0-620-55419-0 (ISBN South Africa) to be distributed among participants at the Conference. Selected presented and peer-reviewed papers will be published either in Visegrad Journal on Bio-economy and Regional Development ISSN 1338-8339 (ISSN Slovak Republic) (http://www.vua.uniag.sk/journal/) or in Journal of Regional Development ISSN 1804-3305 (ISSN Czech Republic) (www.jorede.com) after the conference.
